The [U.S. Committee on the Marine Transportation System \(CMTS\)](http://www.CMTS.gov) serves as a Federal interagency maritime coordinating committee for the purpose of assessing the adequacy of the marine transportation system, promoting the integration of the marine transportation system with other modes of transportation and other uses of the marine environment, and coordinating, improving the coordination of, and making recommendations with regard to Federal policies that impact the marine transportation system. (www.CMTS.gov). On July 23, 2020, the CMTS Coordinating Board approved the establishment of a COVID-19 Working Group (C-19 WG). (https://www.cmts.gov/topics/working_group) Member agencies concurred that the COVID-19 Pandemic was impacting the Marine Transportation System (MTS) and stakeholders in a myriad of ways and that there could be benefit to enhanced interagency discussion and communication.

This Federal guidance and reference catalog was developed by the C-19 WG in response to a recommendation stemming from COVID-19-related industry calls held by the Maritime Administration. The Federal guidance catalog is one of several CMTS actions in an aggressive work plan to respond to several challenges related to the pandemic. The catalog summarizes guidance and resources related to COVID-19 by Federal agency or initiative.
